## A. Chip Seal quote from Muskegon County Road Commission:

Street Administrator Rick Budde submitted two (2) proposal from Muskegon County Road Commission to chip seal and fog seal Kedzie south from Kenwood to Lakewood Road, Kenwood from Russell to Automobile Rd and Kedzie/Parkway from Kenwood to White Lake Drive. The South Kedzie Road estimate is \$27,340.13 and the Kenwood and Kedzie/Parkway estimate is \$65,737.88.

# B. Kenwood house appraisal:
