COMMITTEE REPORTS:

Community Committee:

Trustee T. Verhoeven stated that the committee met on June 17. The committee discussed the Senior millage, she stated she is still waiting to get the more information from Nancy Bramer from Public Health Muskegon County. The committee also discussed Meals on Wheels, meal preparation for seniors, and a senior newsletter. They also held discussion on bringing back the Fox Fest, a community fire pit in park, dog stations in park, teen dances at the Civic Center, and a Thanksgiving fund to purchase meals for the needy in the Village.

Lake Committee:

M. Spencer stated that the dead trees around the lake will need to be taken care of by Village employees. Before doing this, should the Village contact the DNR? Clean up around the lake will be held off until Fall due to all the weeds around the lake.

Park:

Park Superintendent Rick Budde reported that the park rangers have made an improvement in the park. He stated that there are boards that need to be replaced on the boardwalk. Trustee S. Swanson stated that she would like the Council to look into getting a grant for new park equipment.

Streets and Maintenance:

Street Administrator Rick Budde reported that brine has been done on the local roads.

Planning Commission Meeting:

Clerk Bloem reported that the Planning Commission are in the process of reviewing amendments to chapters 3, 4, and 6 in the Zoning Ordinance for spelling and punctuation errors.

Set Calendar:

OLD BUSINESS:

A. Village credit card policy:

B. Update on Village manager

Village Council consensus of the Council is there is no need in pursuing a Village manager.

C. Safety issues causing surveys:

President M. McGahan stated that the surveys that were done due to the dead trees along the lake, this needs to be addressed. There were also issues to be addressed regarding fences and other stuff in the park walkway around the lake.

D. Village attorney policy:

Clerk Bloem will get sample attorney policy from other municipalities and bring back the July meeting.

NEW BUSINESS:

A. Community Watch Program:

President M. McGahan would like to re-start the committee watch program and involve the community and bring it to social media.

B. Taking Village Voice to social media:

President M. McGahan would like to be able to add to the Village Voice through out the year.

C. Dead trees around lake:

Need to contact DNR to find out if we can remove dead trees around the lake.

D. Fireworks/Police:

Clerk Bloem stated that she spoke to the Muskegon Council Sheriff Department and the cost to have a deputy patrolling on July 3rd will be sixty-three (63) dollars an hour. He will post the job, but there will be no guarantee some will sign the posting.

Motion by Trustee J. Semelbauer, second from Trustee M. Spencer to approve the hiring and expenditure of two Sheriff deputies for the night of July 3rd from 8:00 pm to midnight. E. Other

Deputy Clerk Mary Kilmer, addressed the Council regarding four matters as follows:

- 1. Elected Officials Residency Requirements: Deputy Clerk asked President McGahan if he had been living in the Village the past six months to which he replied, "yes."
- 2. Questioned the reason for the surveys of walkway by three lake properties (8 & 92 W. Glen Ave., and 6902 E. Parkway. Answer: Safety issues due to dead trees. Advised property owners should be informed of upcoming surveys as a matter of courtesy to the owner(s).
- 3. Residential communication with Village President. Why doesn't the President answer phone calls? Can't leave a message as no mailbox set up.
- 4. Voting on motion. Council should not vote on any motion if unclear about the reasons why, where, who, and what for are plainly stated.

GOOD AND WELFARE:

Corey Davis, homeowner of 410 W. Kenwood informed the Village Council at the Work Session meeting that his intentions are to have a dumpster hauled in on July 9, 2021 and begin demolition. Mr. Davis made an agreement with the Village Council to have the house leveled July 12, 2021, have the demolition material hauled away and the property cleaned up by July 31, 2021. Homeowner must contact neighbors regarding his intentions.

Motion by Trustee T. Verhoeven, second from Trustee J. Semelbauer to have the Village building inspector extend the demolition permit for 410 W. Kenwood until July 31, 2021. Property owner will have a dumpster brought in on July 9, 2021, house must be leveled July 12, 2021, demolition material hauled away and property must be cleaned up by July 31, 2021. Homeowner must contact neighbors regarding his intentions. Roll call vote: D. Houtteman-Aye, M. Spencer-Aye, T. Verhoeven-Aye, S. Swanson-Aye, R. Morningstar- Aye, J. Semelbauer-Aye, M. McGahan-Ayes. Bob Sikkenga- 739 W. Hawthorne stated that he agrees that more than one person should visit the Village attorney, the Village's regulatory ordinances are good, we do not need a committee to review them. Mr. Sikkenga also stated that the safety hazards around the lake does not warrant a survey.
