Park Administrator Rick Budde reported that a Park Ranger retrieved a garbage lid out of the lake and it is back where it belongs.

President Lichner stated that a Park Ranger informed him that residents are asking if a drinking fountain can be installed near the basketball court. The rangers also thought it would be nice to have a grill installed by the picnic table along the trail, and are also asking if two trash cans to be installed by the benches along the trail, the rangers are picking up a lot of trash in that area.

B. Other:

Mary Kilmer asked for an update on the opening of Clover between Washington to Madison. Rick stated that he is waiting to hear back from Eric Scott from the Muskegon County Road Commission.

Mark Verhoeven stated that he was approached by a Village resident asking why there is not a handi-cap swing in the park for people in wheel chairs. President Lichner stated that when we received the DNR grant through the State one of the stipulations was to make the park ADA compliant. The DNR did not mandate the Village install a handi-cap swing. This may be something the Village can look at installing in the future.
