COMMITTEE REPORTS:

Community Committee:

Trustee Spencer reported that we have the senior gift cards, and we need to decide how we are going to distribute them.

Lake:

Park Superintendent Rick Budde stated that he has been working on the end of the fishing dock in the park. The post that was driven into the lake have come moved back four feet from the ice. Trustee Swanson stated that we contacted the company that put in the post and they came out to inspect them and they said it was safe. Rick stated that the company recommended that he put a 3" steel plate along one side, he did that ran four timber bolts through the steel. Rick is cutting the end of the dock off to get it out of the water.

Ordinance Enforcer: Report submitted to Council for review.

Trustee Spencer questioned the report on 757 Michigan regarding someone living inside a motor home. Trustee Spencer stated that it sounds like he made contact with the person living in the motor home but not the owner of the property. He should be talking to the owner of the property, he is responsible. A letter needs to be sent the homeowner and then followed up by the Ordinance Enforcer.

Park:

Park Administrator Rick Budde reported that they have been working on the fishing docks that the ice has damaged. Both docks are going to need a lot of work done to them. He has also been repairing picnic tables.

Streets and Maintenance:

Street Administrator Rick Budde reported regular maintenance on roads.

Planning Commission Meeting:

Clerk Bloem reported that the Planning Commission is working on Chapter 9 of the Zoning Ordinance.

H.R. Committee:

Trustee Semelbauer stated that there were three applicants for the deputy clerk and clerk's position. The first applicant was interested in a full-time position, the second applicant Holly Frees'is interested in the deputy clerk's position and has no problem doing a job share with Cheryl Edsall and, the third applicant Susan West is interested in the clerk's position, only downfall is that she may be elected at the next election.

A. Budget work session meeting:

B. Road Policy:

President Sikkenga is recommending to Council to appoint Susan West as Clerk when position comes available, and Holly Frees to Deputy Clerk to begin on May 1, 2022.

Spencer, second from Trustee S Swanson to accept to accept the recommendation from President Sikkenga to appoint Susan West as Clerk when Clerk Bloem leaves and appoint Holly Free to take over as Deputy Clerk on Maty 1, 2022. Roll call vote: M. Spencer-Aye, S. Swanson-Aye, J. Semelbauer-Aye, and President R. Sikkenga-Aye. Ayes: 4, Nays: 0. Motion Carried.

D. Larry's Pay:

President Sikkenga Larry had surgery is off work on workman compensation. Does the Council want to make up Larry's wages that he does not receive from Workmen Compensation? President Sikkenga feels the Village should not pay 100% of Larry's wages. Can Larry train while he is off, watching videos etc. Trustee Spencer stated that this should be approved by his doctor and workman's comp. This needs to be added to the budget work session meeting.
