# Village of Lakewood Club Meeting Minutes for December 18, 2023

CALL TO ORDER: Meeting called to order by President R. Sikkenga at 7:00 pm.

#### PUBLIC COMMENT:

Kevin McCabe, 69 W. Linden, stated that there are some serious flaws in the garbage collection ordinance, if you recall he was in here a while back and that he made mention about him being a senior and that he does not use the garbage service as much as other residents. He stated that there was mention in another meeting about some residents piling their garbage up with bags outside of their can but that he does not have that, he only uses it once a month and that his is not even topped. He stated that under the ruling for the use tax he is allowed to limit his use so he is asking to limit his use to only once a month, instead of the hundred and fifty-three dollars and sixty cents, that would equal thirty-eight dollars and forty cents. He stated that he is asking the council to recognize that law, that it is a Supreme Court Ruling by the way, Michigan Supreme Court that is. He stated he is allowed to limit that use of that because you're allowing other people to pile it up and that the Ordinance Enforcer is not taking any notice of that. He stated that he would like the council to recognize his use to being limited and that you may want to take note of that with many Seniors in the community that maybe only have one or two people in a household not like a houseful of school kids or whatever, he sees them piled over and three or four bags around the perimeter weekly. He only uses it once a month and it's not even topped so he asked the council to recognize and that they would be much more excited about the next public comment.
